

The American Legion, Department of Wisconsin Sweepstakes
OFFICIAL RULES

1. **ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.** Making a donation to The American Legion, Department of Wisconsin will not improve your chances of winning. Sweepstakes is void in New York and Florida or where otherwise restricted or prohibited by law. To enter The American Legion, Department of Wisconsin Sweepstakes (the "Sweepstakes"), you: (i) must be a citizen of the United States or a lawful permanent resident of the United States; (ii) must be 18 years of age or older at the time of entering the Sweepstakes; and (iii) must not be considered a minor in your state of residence. Employees, officers and directors of The American Legion, Department of Wisconsin (the "Sponsor"), its respective parent, subsidiaries, licensees, agencies and affiliates ("Sweepstakes Entities") and members of the immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household (whether related or not) of such individuals are not eligible.

(One entry form per envelope will be sent in the envelope provided.) All entries must be post-marked on or before January 16, 2019.

3. **PRIZES**

One Grand Prize: Your choice of \$20,000 cash or a vehicle voucher from Stumpf Ford in Appleton, WI. (retail value of \$15,000). If the Grand Prize Winner selects the automobile, he or she must be a licensed driver and will be required to provide proof of insurance at the time of winner verification and take delivery of the vehicle at the dealer location. The selected winners will be notified by Sponsor via telephone, mail or the email address supplied during entry at Sponsor's sole discretion. The odds of winning depend on the number of eligible entries received. The Sponsor's decisions are based on its sole discretion and interpretation of these official rules, and are final and binding in all respects. If a potential winner does not respond to the prize notification within ten (10) business days from the first notification attempt, then such entrant will be disqualified and an alternate winner will be selected.

Sponsor, its advertising and promotion agencies and all of their respective parents, affiliates, subsidiaries, agencies, agents and representatives and their respective employees, officers and directors are not responsible and shall not be liable for: (a) any human error which may occur in the processing of entries; (b) lost, late, or misdirected entries; or (c) any condition caused by events that may cause the promotion to be disrupted or corrupted.

7.
