

*OFFICIAL RULES: The American Legion, Department of Wisconsin Sweepstakes

- 1. ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.** Making a donation to The American Legion, Department of Wisconsin will not improve your chances of winning. Sweepstakes is void in New York and Florida or where otherwise restricted or prohibited by law.
